# How can Legal Aid NSW help me?

You can get free legal advice and assistance at Legal Aid NSW. You may also be able to get a lawyer to represent you in court if you're eligible.

Legal Aid NSW can help you with:

- Applications for Apprehended Domestic Violence Orders (ADVOs);
- Disputes about children, divorce and dividing property;
- Child support;
- Children's Court matters about the care and protection of children;
- Mediation to help resolve disputes about children or property (family dispute resolution);
- Financial problems such as paying the mortgage, credit and debt, and housing;
- Immigration issues such as residency applications where the marriage or relationship has broken down due to domestic and family violence;
- Information and referrals about the Victims' Support Scheme;
- Representation for defendants in cross applications for ADVOs where the defendant is also a protected person and has experienced domestic or family violence themselves;
- Representation for defendants in ADVO matters (in certain circumstances);
- Representation for defendants in domestic violence criminal charge matters.

## Can I get a lawyer to represent me?

Yes. Sometimes Legal Aid NSW can pay a lawyer to represent you, for example if you need ongoing legal help or need to go to court. This is called a grant of legal aid or 'getting legal aid'.

Not everyone can get legal aid. Legal Aid NSW prioritises people who are experiencing or at risk of domestic or family violence. It is best to get legal advice before you apply for legal aid.

# Can I get legal aid for any type of case?

Legal Aid NSW does not represent people in every type of case. Talk to a Legal Aid NSW lawyer or LawAccess NSW about whether legal aid is available for your situation.

# Can I get a lawyer to represent me in my ADVO case?

Most applications for Apprehended Domestic Violence Orders (ADVOs) are made by the police. In these cases the police prosecutor will appear in court and make the application for your protection. You don't need a lawyer for the ADVO application. You can speak with a Legal Aid NSW lawyer about other legal issues that might be related to the domestic violence.

If you want to make a private application for an

ADVO, Legal Aid NSW may be able to assist you. The Women's Domestic Violence Court Advocacy Service (WDVCAS) can refer you to a lawyer or help you apply for legal aid. Call **1800 WDVCAS** or **1800 938 227.** 

## Can an ADVO defendant get legal aid?

The person an ADVO application is made against is called the defendant. A defendant in an ADVO application can only get a grant of legal aid in exceptional circumstances. More information is available from a local Legal Aid NSW office or from LawAccess NSW on **1300 888 529**.

# What if I have an AVO and someone else applies for an AVO against me?

This is called a cross application. In these circumstances, you are also a defendant. Cross applications can be complicated and it is important that you get legal advice or contact your local WDVCAS (for women).

You may be able to get a grant of legal aid to defend the cross application, especially where you have experienced domestic or family violence yourself. For more information contact LawAccess NSW on 1300 888 529, Legal Aid NSW or your local WDVCAS.

# Will I get a lawyer who works at Legal Aid NSW?

If you qualify for a grant of legal aid, Legal Aid NSW will pay for your lawyer. That lawyer may work for Legal Aid NSW or be a private lawyer paid by Legal Aid NSW.

#### What is a conflict of interest?

Sometimes a lawyer who works for Legal Aid NSW may not be able to represent you because the other party has been or is currently assisted by a Legal Aid NSW lawyer. This creates a conflict of interest.

A conflict of interest does not mean that you are not eligible for legal aid. If a Legal Aid NSW lawyer is unable to help you because of a conflict of interest, you will be referred to another lawyer who can assist you.

#### **Domestic Violence Duty Scheme**

(DVDS) These are lawyers paid by Legal Aid NSW who have expertise in domestic and family violence. They can help you with an ADVO matter, and provide advice and referrals for other legal issues such as family law, victims support or debt. The DVDS operates in some Local Courts on AVO list days. Call your local WDVCAS or LawAccess NSW on 1300 888 529 for more information.

**Domestic Violence Unit, Legal Aid NSW 9219 6300** Legal advice, assistance, referral and representation as well as social work support and financial counselling for victims of domestic and family violence.
